

INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF THE POLICE AND CRIME COMMISSIONER FOR HERTFORDSHIRE GROUP

AUDIT COMPLETION CERTIFICATE

In our audit report dated 27 February 2026 we stated that we could not certify that we had completed the audit of the Police and Crime Commissioner for Hertfordshire Group ("the OPCC") for the year ended 31 March 2025 in accordance with the requirements of the Local Audit and Accountability Act 2014 and the Code of Audit Practice published by the National Audit Office (the "NAO") in November 2024 on behalf of the Comptroller and Auditor General (the "NAO Code of Audit Practice").

We could not certify completion at 27 February 2026 because at that date we were unable to confirm that we had completed our work in respect of the OPCC's Whole of Government Accounts consolidation pack for the year ended 31 March 2025 because we had not received confirmation from the NAO that the NAO's audit of the Whole of Government Accounts was complete.

Following receipt of the confirmation from the NAO that the NAO's audit of the Whole of Government Accounts is complete, we have now completed our work in respect of the OPCC's Whole of Government Accounts consolidation pack for the year ended 31 March 2025.

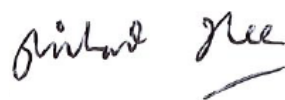
No matters have come to our attention since the date of our audit report, 27 February 2026, that would have had an impact on our reporting by exception on whether we had identified any significant weaknesses in the arrangements that have been made by the OPCC to secure economy, efficiency and effectiveness in its use of resources.
